WEBSTER COUNTY AGRICULTURAL ASSOCIATION

Shall the Webster County Agricultural Association be allowed to levy a property tax not to exceed 2.0 (two) cents per one hundred dollars of taxable valuation in excess of the limits prescribed by law until and including fiscal year 2027-2028 for the purpose of general operation of the Webster County Fair and to increase the restricted funds base by \$197,271 or 460.83% over the allowable growth percentage.
